

NOTIFICATION

It is notified for information of all concerned that keeping in view of the extraordinary situation arising out of the persistence demand of the students, and on the recommendation of a Committee, the Vice-Chancellor, has accorded permission to grant a mercy chance to the students of various UG/PG Courses, who couldn't pass the course within the admissible chances as per ordinance which shall be subject to fulfillment of following criterion/conditions:

- The students who got registered/enrolled themselves for their particular course in the year 2014 onwards for PG and 2017 onwards for UG have already availed/exhausted all their admissible chances as provided in the Ordinance(s) till the last exam i.e., May/June 2024 shall only be eligible for this Mercy chance. If anyone who is left with any admissible chance to pass the concerned programme/course shall not be eligible for this Mercy chance.
- 2. The examination for Mercy chance shall be held in offline mode only.
- 3. The examination for this mercy chance may tentatively be conducted in the month of June/July, 2025.
- 4. The examination form along with fee shall be filled up through online mode. The students are advised that before submission of online examination form and fee, they must check/ensure their eligibility, and in case of any doubt, they must confirm it from the Examinations Branch. If any "INELIGIBLE STUDENT/CANDIDATE" submits his/her examination form and fee without ensuring his/her eligibility, then he/she will be solely responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case.
- 5. All the students desirous of availing this chance are advised to read the following conditions/instructions carefully:
 - i) The schedule of examination/declaration of result will be notified depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of result.
 - ii) The Mercy chance is admissible to complete the Degree (course) for such students who have re-appear in one or more papers (subjects).
- 6. The students may appear in one or more theory paper(s) only in which he/she has re-appear as per their syllabus, scheme of examination and Ordinance applicable on them at the time of their regular examination.
- The Examination form panel for this mercy chance shall be live from 03.04.2025 to 26.04.2025 on the University Portal

- 9. The examination for mercy chance to B. Pharmacy & M. Pharmacy subject to the PCI conditions and LLB, BA LLB and LLM subject to the Bar council conditions.
- 10. The candidates enrolled/registered in 2014, 2015, 2016, 2017, 2018, 2019 & 2020 Batch in PG and 2017 & 2018 Batch in UG, the Mercy chance examination shall be allowed subject to the following:
 - i) The scheme and syllabi for Mercy examination will remain same as that was applicable on PG and UG above mentioned batches.
 - All such students under the Mercy chance shall appear for exam at their own risk ii) subject to the availability of nomenclature matching with the prescribed syllabus applicable from 2014. If any dispute remains there in this behalf, the committee will decide this after the examination, if required.
 - All such candidates shall not claim for nomenclature/syllabus according to their iii) registration year and to this effect, they will also be required, to submit an undertaking at the time of filling exam form.
