Terms and conditions:

- a) The Chairperson, members and the special invitee shall have a term of two years.
- b) The quorum for the meeting, including the Chairperson, but excluding the special invitee, shall be three.
- c) In considering the grievances before it, the USGRC shall follow Principles of natural justice.
- d) The USGRC shall send its report and recommendations, if any, to the Principal of the College relating to the grievance/Head of the department/School/Institution with a copy thereof to the aggrieved student, within 15 days of the receipt of the grievance.
- e) Any student aggrieved by the decision of the University Student Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within in a period of fifteen days from the date of receipt of such decision.
