The interested bidders shall have to pay mandatorily Tender fee of Rs. 3000 (Three thousand only) and refundable Earnest Money Deposit (EMD) of Rs. 9000/-by demand draft/ College receipt/ QR code of college bank account in favour of Principal, S.M.R.J. Government College, Siwani (Bhiwani) payable at Siwani.

2. Tenders are hereby invited in single stage in one cover Technical Bid and Financial Bid for the Purchase of ten Electric Scooter. The Technical and Financial Bids would be opened on dated 1.7.2024 ant 11:00 AM.

### **Part- I Technical Bid shall consist of following documents:-**

- (i) The Bidders shall have to pay for the Tender and EMD Fees by demand draft/ College receipt/ QR code of college bank account.
- (ii) Only authorised dealer/ authorised distributors of the concerned company can apply for the branded items. The certificate regarding authorised dealer/ authorised distributor issued by the company is required with the tender.

**NOTE:- copies of the above documents should be attached with the bid as proof.**

**Part II** The Technical and Financial Bid along with all relevant supporting documents is to be submitted in off-line mode in physical form by speed/ registered post or physically by due date and time in the O/o The Principal, SMRJ Government College, Hisar- Rajgarh Road, Near Civil Hospital Siwani, N.H. 52, Siwani, (Bhiwani) Pin Code-127046.

The Technical and Financial Bid will be opened on 1.7.2024 at 11:00 AM by the Bid Committee in the presence of tenderer or their authorized representatives who may wish to attend. In case the date of opening of tender is declared holiday by the Government, tenders shall be opened on the next working day following the closed day at the scheduled time.

3. Your rates should be F.O.R. S.M.R.J. Government College, Siwani (Bhiwani) and must include all freight charges, postage, packing, cartage, duties, Taxes excluding GST, if any, which should be indicated in the remark's column of the Annexure-A (PRICE BID) rates or imposition whatever leviable in respect of supplies, at the time of submission of tender. If however, thereby any introduction of new duties, taxes of charges by the Government of India or State Government on the finished goods tendered for after the date of submission of tender, these will be allowed in addition to the accepted rate. Firms sending goods by Road Transport should arrange the delivery of the goods, at the premises of S.M.R.J Government College, Siwani (Bhiwani). You are to sign and to mark the date in the Tender, the Schedule to and the —Specification and Conditions attached to the Annexure-A. You should not make any alteration in or addition to any of the documents connected with the Tender. You are to initial any erasure or alteration that may have been made in the form by you.
4. You will be notified in writing, if you are a successful, of acceptance of your tender. Till then you have no right to assume, that your tender has been accepted. and if you disregard this warning and make any arrangement or incur any expenditure in anticipation of receipt of notice of acceptance, you will have no claim for compensation.
5. The security deposit shall be as per policy issue by State Government vide G.O. No. 2/2/2016-4IBII(2) dated 20-10-2016. The Security deposit to be furnished must be in one or other of the following forms:—  
Tender Fee and EMD should be deposited by Demand Draft/ college receipt/ Net Banking favour of Principal, S.M.R.J. Government College, Siwani (Bhiwani). In case of DD no interest will be paid while the contract is in force.
6. If you are a successful tenderer, your earnest money deposit will be returned after one year. Earnest money of unsuccessful tenderers (unless forfeited) will be returned immediately after rejection of their tenders.

7. The approval or rejection of the tenders rests with the Principal, SMRJ Government College, Siwani (Bhiwani) who reserves the right of rejecting any tender or any item in a tender without assigning any cause. The lowest tender will not be necessarily accepted.

9. Payment of bills will be made through Principal, S.M.R.J. Government College, Siwani (Bhiwani) after the inspection of committee. No payment will be made in advance for any supplies under this tender.
10. No assistance for obtaining import license will be rendered by this Department.
11. No priority certificates or letters to Railway or other authorities will be given to you to facilitate the carrying out the contract.
12. The delivery of E sooters must be within 30 days. The authorised service station should be located within 30 km from S.M.R.J. Government College, Siwani
13. Defected goods will be outrightly rejected and must be replaced.
14. **Tender accompanied by the Tender fee and earnest money deposit will only be considered. Only authorised dealer/authorised distributors will be entertained. The certificate regarding authorised dealer/authorised distributor issued by the company is required with the tender.** Conditional tender will also not be considered.
